GRAND SLAM AGGREGATE WINNER

Heaviest Aggregate weight of 3 of the 4 fish (1 must be a Speckled Trout) entered in the tournament will be the winner. If weight is tied, earliest completed slam determines winner.

RULES & REGULATIONS 2023

All contestants MUST follow the laws of the Florida Wildlife Commission.

- **1.Rules & Regulations** Registration starts September 15, 2023, at Stinky's Bait Shack. You can register in person, or by phone 850-622-2248 or online at www.StinkysBaitShop.com. Registration forms must be received 24 hours prior to weigh-in. Weigh-in begins at 8am October 1st at Stinky's Bait Shack. Anglers may weigh in fish 10am-6pm daily through Saturday, October 28th. Registration Fees are non-refundable. Participants are required by law to abide Florida Wildlife Commission (FWC) fishing regulations. **PLEASE NOTE FLOUNDER SEASON CLOSES OCTOBER 15**TH
- **2. Tackle:** ALL FISH MUST BE CAUGHT ON HOOK AND LINE WITH LIVE OR ARTIFICAL BAIT ONLY. NO CAST NETS, ENTAGLEMENT NETS, GIGS OR TRAPS ALLOWED.
- **3. Participation:** Participants are responsible for knowing and abiding by Stinky's tournament rules and the Florida Fish and Wildlife Commission regulations, pertaining to licenses, size and bag limits, and any other regulations that may apply. Participants agree and consent to the use of any photographs in which they appear by the tournament; to include, ANY Stinky's Fish Camp and Stinky's Bait Shack website, social media outlet, and sponsor websites.
- **4. Weigh-Ins** Fish are to be weighed-in at Stinky's Bait Shack during normal business hours.

NEW RULE: All fish must be gutted and will be weighed to the thousandth of a pound.

Pompano, Redfish, Speckled Trout and Flounder.

Anglers are allowed to weigh ONE fish per species daily! The angler that caught the fish must be the one to weigh in! 1st 2nd & 3rd place winners will be awarded for each species. The Aggregate Grand Slam will be the heaviest Aggregate weight of 3 of the 4 fish (1 must be a Speckled Trout) entered in the tournament will be the winner. If weight is tied, the earliest completed slam determines the winner. Anglers are permitted to have one fish per species on the leader board daily. Any fish that appears to have been penned, mangled, mauled, mashed, or otherwise altered will not be scored. Fish must be caught "RECREATIONALLY" - NO COMMERCIAL OR CHARTER CATCH ALLOWED!
