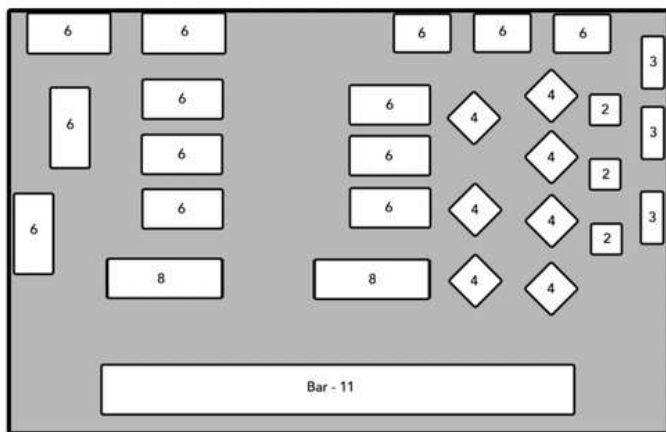

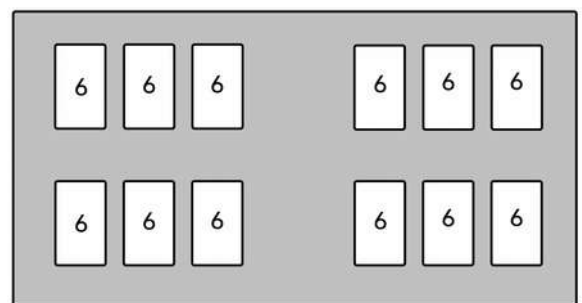

PATIO: 72 Seats

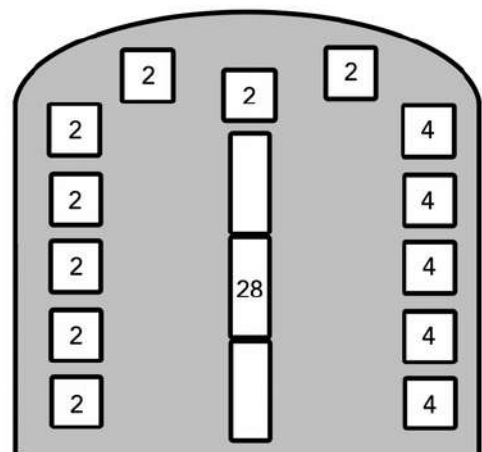

PRIVATE PARTY AGREEMENT

Galveston Bay Brewing agrees to provide the food and services described in the attached event description, pursuant to the following terms and conditions:

Pre-Event Deposits and Payments:

- A 50% deposit of the event's estimated total, as well as a signed copy of these terms and conditions, is required to reserve the event date and confirm our services.
- The Final balance of the event's estimated total must be paid the day of the event.
- Galveston Bay Brewing reserves the right to cancel an event if payment schedules are not met, credit card charges are declined/disputed, or checks are returned.
- After the event is completed, Galveston Bay Brewing will provide the customer with a final invoice (further described below) which may or may not differ from the estimated total.

Pre-Event Contract Revisions:

- All menu changes, bar selections, and final head counts must be received seven (7) business days prior to the event.
- If a final head count is not received by the deadline (seven business days prior to the event), the customer will, at minimum, be charged for the guaranteed number of guests stated in the attached event description. In the event of a plate count increase, the price per plate will be adjusted according to the final plate count.
- If menu changes or bar selection changes are requested past the deadline, late requests may or may not be granted.
- Any items added or removed from the event description after this agreement is executed will require a NEW contract signature.

Service Charge:

- Service Charge of 20% of Food and Beverage total will be charged for all parties.
- Service Charge for contracted third-party staff cannot be added to the final invoice and must be paid directly to the vendor.

Post-Event Final Invoice and Additional Fees:

- The customer will, be charged for the allotted time described in the attached event description. If the allotted time described in the event description is delayed or extended, the customer will be charged for the additional time.
- The customer will, be charged for the number of plates described in the attached event description. If the number of plates is exceeded, the customer will be charged for the additional plates.
- Any missing/damaged equipment or property belonging to Galveston Bay Brewing or third-party vendors will be billed to the customer.

Cancellation:

- Cancellation of the event will incur the following cancellation fees.
 - 30 days or more prior to the event date = 3% of deposit plus tax.
 - 6-29 days prior to the event date = 50% of deposit plus tax.
 - 5 days or less = no refund.

Outdoor Events:

- Booking Galveston Bay Brewing is on a “rain or shine” basis. If there is bad weather, it is the customer’s responsibility to try to move the event indoors or to a suitable covered outdoor area with a tent option (additional tent rental costs will be billed to the customer). If a customer opts to cancel instead, the cancellation policy applies (including deposit forfeiture.)

Vendors:

- Vendor services (such as live entertainment) must be finalized seven (7) business days prior to the event; any adjustments after that date cannot be guaranteed.
- If contracted third-party staffing time is delayed or extended, the customer will be billed for additional time.

Safety:

- The customer and its employees, invitees, and guests shall at all times be fully responsible for complying with safety laws, rules, regulations, orders, and ordinances, as well as any Galveston Bay Brewing instructions, applicable to the customer’s event.

TERMS & CONDITIONS

Limitations on Damages:

- Neither party shall be liable for failure to perform its obligations under this agreement if such failure is caused by an act of God, war, civil disturbance, strike or other events of force majeure beyond the control of the non-performing party and such party takes reasonable measures to mitigate the effects thereof. In such an event, the customer's pre-event deposit(s) will be refunded.
- Notwithstanding the foregoing, in an event of force majeure 5 days or less from the event date which causes the customer to cancel the event, the customer must pay for fees and costs incurred in the event's preparation, including, but not limited to, food, beverage, staffing, or rentals. Galveston Bay Brewing may retain all or a portion of the customer's pre-event deposit(s) to cover such costs.
- In no event shall Galveston Bay Brewing be liable to any other party for (and Customer hereby waives all rights to) any speculative, consequential, or punitive damages for any event or service cancellation, breach of, or default under this agreement.

Release and Indemnity:

The Customer agrees to and shall release and waiver Galveston Bay Brewing, its agents, employees, contractors, vendors, and officers ("Indemnified Parties") from all liability for injury, death, damage, or loss to persons or property sustained in connection with or incidental to Galveston Bay Brewing performance under this Agreement, even if the injury, death, damage or loss is caused by an Indemnified Party's negligence (whether sole, joint or concurrent), gross negligence, strict liability, premises liability, willful and malicious conduct, breach of contract, or action in equity if any.

The customer agrees to defend, indemnify, and hold harmless Galveston Bay Brewing, its agents, employees, contractors, vendors, and officers from and against any and all claims, losses, damages, causes of action, suits and liability of every kind and character, including all expenses of litigation, court costs, and attorneys'; fees, for injury to or death of any person or for loss of or damage or loss to any property arising out of or in connection with Galveston Bay Brewing services by customer, its employees, agents, licensees, caterers, third party contractors, invitees or guests.

Such indemnity shall apply to the consequences of the indemnified parties' own culpable conduct and liability, including but not limited to (a) negligence, gross negligence, strict liability, premises liability, product liability, willful and malicious

Release and Indemnity, continued:

conduct, breach of contract, and actions in equity, if any, regardless of whether such culpable conduct was the sole, proximate or producing cause of the claims, or whether such culpable conduct was the proximate or producing cause jointly and concurrently with the culpable conduct, if any, of the customer or any other individual or entity; and (b) the consequences of customer's own culpable conduct and liability in connection with his or her event, if any, regardless of whether such culpable conduct was the sole, proximate, or producing cause of the claims. Any person signing this contract represents and warrants to Galveston Bay Brewing that he or she is duly authorized to sign for and bind the customer and deliver this contract.

Please Note: This contract will be honored if signed and returned with a credit card deposit within 5 Days hours from the time and date printed on this document. After that, if Galveston Bay Brewing has not received the client's signature, credit card information, AND full deposit, the event date may be released and given to another party and the terms above may change.
