THANKS FOR INQUIRING ABOUT OUR CATERING SERVICE AT ADOPTED DOG BREWING! WE LOVE WHAT WE DO, AND WE KNOW HOW TO HAVE A GOOD TIME. YOU INVITE THE RIGHT PEOPLE, AND WE'LL DO ALL THE REST.

ADOPTED DOG BREWING WAS DESIGNED TO ALLOW GUESTS TO MOVE FREELY THROUGHOUT THE BREWERY DURING THEIR VISIT, BUT WE QUICKLY REALIZED THERE WAS A DEMAND FOR A SLIGHTLY MORE PRIVATIZED AREA FOR SPECIAL EVENTS.

BRILLO'S PAD WAS CONSTRUCTED TO OFFER GROUPS OF DIFFERENT SIZES AN AREA THAT THEY COULD CONGREGATE WITH JUST THEMSELVES, WHILE STILL ABLE TO CO-MINGLE WITH OTHER BREWERY PATRONS ON THE DECK, UNDER THE PATIO, AT THE BAR, OR IN THE GAME ROOM.

BRILLO'S PAD OFFERS PARTIES A MOSTLY COVERED PRIVATE AREA WITH BOTH FANS & HEATERS TO HELP TEMPER THE OUTSIDE WEATHER JUST A LITTLE BIT. FLEXIBLE SEATING ARRANGEMENTS WILL ALLOW PARTIES IN THE 35-50 PERSON RANGE BOTH THE OPPORTUNITY TO SIT TO EAT, AS WELL AS MINGLE AND SOCIALIZE.

THERE IS ALSO AN OPTION TO ACTIVATE BRILLO'S PAD'S PRIVATE BAR. IN DOING SO, YOU WOULD HAVE THE OPPORTUNITY TO CHOOSE ANY THREE OF OUR BEER OFFERINGS TO HAVE ON TAP FOR QUICK ACCESS, ADDITIONAL SPIRIT AND COCKTAIL OFFERINGS, AND A PRIVATE BARTENDER DEDICATED TO YOUR PARTY.

Special Event / Catering Terms

GENERAL CONDITIONS: Minimum 25 people to qualify for all packages – max 3-hours. Groups of 50 or more people will need to speak with the Event Coordinator to discuss package & spacing options. In the event a party is booked on a date after live music has been scheduled, a combination of patio tables and a portion of the deck will be reserved for the party in a flexible manner. Rental fees waived for non-profits.

DEPOSIT AND PAYMENT: A \$150 deposit is required at the time the contract is signed in order to secure the event date. Deposit is non-refundable. Deposit can be made here: <https://bit.ly/BrillosPad>

For entire brewery buyouts, fifty (50%) percent of the minimum spend will be due fourteen (14) days prior to event date. Any remaining balance of the minimum spend is due day of your event.

FINAL HEADCOUNT, BEVERAGE SELECTIONS, AND MENU SELECTIONS: A guaranteed number of people attending, final menu, and final beverage selections are due two (2) weeks prior to the scheduled event.

Once guaranteed head count is made, it may not be reduced. An additional \$5.00 per person charge will be added to any additions made after the final deadline in addition to the set price per guests. Unfilled reservations will be billed.

CANCELLATIONS: Cancellations must be made within one week prior to the event to avoid any penalties beyond forfeiture of deposit. If cancellation is made after 6 days or less of your event, \$10 per person of estimated headcount at time of agreement will be charged to credit card on file.

During the Holiday season (November – January & the month prior to Mardi Gras) a two (2) week cancellation notice is required. If a party cancels less than two (2) weeks before the event fifty (50%) percent of the total will be charged.

SERVICE CHARGE: A 22% service charge is added to the total invoice to cover event related items such as: gratuity, staffing, set-up, break-down, chafing equipment and fuel tables, chairs, etc.

FOOD & BEVERAGE MINIMUM: The minimum is based on food and beverage net sales; the minimum does not include taxes, service charge, or rental fee. If the event does not meet the required minimum amount, the client is responsible for the difference, which will be charged to the card on file unless otherwise noted. To-go beer and merchandise cannot be purchased to reach the minimum spend.

TAX: All events are subject to state tax. If you are tax exempt, your tax registration number and a certificate of exemption must be returned with your signed copy of this contract.

WEATHER: In the case of inclement weather as it relates to private outdoor events, within Brillo's Pad or on the deck, Adopted Dog Brewing will make every effort to accommodate your event under the patio or inside or by working with you on an alternate date.

If Adopted Dog Brewing provides reasonably comparable accommodations and client chooses to cancel event due to weather, client is responsible for \$5 per estimated headcount.

In the event of weather closure from Adopted Dog Brewing, the client will receive a full refund, including the deposit.
